Addictions & Mental Health

We provide a full continuum of free addiction, mental health, and concurrent disorder services. This includes our 24/7 Crisis Line, Crisis Walk-in Clinic, crisis outreach programs, outpatient Concurrent Disorders counselling, Harm Reduction supplies, and bed-based withdrawal management and treatment services. We provide both individual and group supports. Our team will help you to develop a plan that meets your individual goals.



Employment Services

We're here to help everyone in the community find meaningful work. Our employment services connect you with local employers and job opportunities. We can assist with job searches, skills assessment, resume polishing, job interview preparation, finding education and training options, and even show you exclusive job openings.



Housing

There are many ways that we can help people who are experiencing homelessness or who are at risk of experiencing homelessness. We focus not only on getting a roof over your head in the short term, but also in helping you connect with ongoing services and support to find and maintain a long-term, permanent place to live. Our services range from emergency shelter, transitional and supportive housing options.



Justice

We offer client centered community based and residential environments that provide strength based individual and group focused education, assessment and counselling to youth and adults involved in the legal system. The goal of these services is to provide people with alternative solutions to legal charges and formal court proceedings, so that individuals can avoid a criminal record or even jail time by taking responsibility and making amends for unlawful actions.

Agency programs are funded by all three levels of government, user fees, donations and grants from individulas, foundations and businesses.
